
The Grant

• **\$87 million** awarded to the University of Kentucky by the National Institute on Drug Abuse and the Substance Abuse and Mental Health Services Administration

• **4 institutions** funded: University of Kentucky, Ohio State University, Boston Medical Center and Columbia University

The Communities

• 16 counties in Kentucky:



County Selection Process

120 Kentucky counties

48 counties with ≥ 25 opioid overdose deaths per 100,000 in 2017

435 counties without suppressed overdose data (≥ 5 opioid overdose deaths)

- **4**28 counties with needed justice infrastructure
 - ▶25 counties with needed treatment infrastructure
 - **4**19 counties with needed public health infrastructure

616 counties not already involved in major UK intervention projects

The Goals

• To reduce opioid-related overdose deaths by **40%**

• To collaborate with state and community partners to implement evidence-based interventions to save lives, help people receive recovery support services, reduce harms, and inform the nation on what strategies will help us heal from the opioid crisis
