### Peer Recovery Coach (RC) Manual

This manual shares the content and training resources developed by the HCS-KY team to implement linkage and retention programs with peer recovery coaches. The linkage program aims to connect individuals with OUD to MOUD treatment. The retention program aims to retain individuals already in MOUD treatment who may be at risk for dropping out. The training curriculum for both programs is ~150 hours and focuses on training RCs to be field ready to work with clients, help bust barriers to engagement in MOUD, and ensure access to overdose education and naloxone for prevention of fatal overdose. ### **Care Navigator Manual**

This manual shares the content and training resources developed by our teams to implement MOUD linkage and retention programs with nurse or social work care navigators. The training curriculum is ~50 hours and covers topics such as OUD Specific Care Navigation Trainings, Effective Client Assessment, Navigating and Establishing Healthy Boundaries in Practice, and Opioid Education and Naloxone Distribution.
